

## EXHIBIT A ENGAGEMENT FEE SCHEDULE

- 1. For all Engagements performed, the rates are for actual stage time, <u>plus 2 hours of</u> <u>prep-time</u>: **\$150 per hour**.
- 2. Materials provided are the exclusive intellectual property of Full Circle Cannabis Consultations, notwithstanding certain materials labeled as public documents.
- 3. When required, Host or School is responsible for providing copy services in all cases. F.C.C.C. shall make master copies available to the host or school 2 weeks prior to the event or class.
- 4. F.C.C.C. reserves the right to provide additional materials, in the form of Basic Binders and/or DVDs, for all participants or students, and the price of such Binders / DVDs shall be included in the costs of tuition and billed to the host or school. Host or School is responsible for payments to F.C.C.C. for all Binders / DVDs so allocated, upon completion of the Engagement.
- 5. Mileage Rates:

## .54 cents per mile, round trip.

- 6. Drive Time: First 240 miles / 4 hrs. round trip are free; additional driving billed at: \$75/hr.
- 7. Air-fare: For all situations requiring air travel to and from the engagement or class, host or school shall pay for 100% of the air-fare, up-front. Seats must be in business-class or first-class.
- 8. Rental Car(s): For all situations requiring rental car, we require a "luxury" car. In lieu of a rental car, daily cab-fair or a personal car and driver (for all necessary travels between site of engagement, meals and overnight accommodations) may be provided by the Host or School.
- 9. Overnight Accommodations: For all situations requiring overnight accommodations in the performance of our services, host or school shall pay 100% of lodging fees, at or before the date of the Engagement. All hotel or motel accommodations must be 3 stars or higher. Personal accommodations by Host or School may be accepted, in lieu of hotel or motel, upon prior arrangements.
- 10. Payment Receipt: For all situations involving air-fare and rental car or overnight accommodations, Host or School agrees to provide the necessary funds to secure said

## 11. Ending the Relationship:

**By You:** You are free to terminate our services for any reason, before the event or class occurs, by providing us with a dated, written and signed notice, within 1 calendar week of the date of the event or class and by paying any expenses incurred by us prior to receiving said notice, that were undertaken in the furtherance of this contract.

**By Us:** Full Circle Cannabis Consultations are free to withdraw our services at any time for good cause, provided that written, dated and signed notification is made to you in a timely fashion. Such good cause includes any misrepresentation of or failure to disclose facts on your part that are relevant to this contract, any requests made by you that we engage in unethical or illegal conduct and any failure on your part to maintain agreed upon financial arrangements with us. We also reserve the right to terminate this agreement if we find ourselves unable to fulfill the terms of this agreement due to scheduling conflicts or personal emergencies. In all such eventualities, you are only liable for payment of your portion of the expenses required in the service of this agreement up to the time that this agreement is terminated. Where no such expenses have been incurred, no payments are required.
